# REQUEST FOR PROPOSALS (RFP)

Assessment Services for Cyclical Reassessment, Annual Trending, and Maintenance Randolph County, Indiana
Assessment Years 2027–2030

#### 1. Overview

Randolph County, Indiana, is soliciting proposals from qualified assessment firms to perform services in compliance with Indiana Code § 6-1.1-4, Title 50 IAC, and the Indiana Department of Local Government Finance (DLGF) requirements. This contract covers cyclical reassessment, annual trending, and maintenance for assessment years 2027 through 2030.

## 2. Scope of Work (Exhibit A – Scope of Services)

The Contractor shall:

- Perform annual cyclical reassessment (25% per year) of all real property.
- Conduct annual trending of all real property.
- Provide maintenance assessments (new construction, demolitions).
- Prepare and present land order values and neighborhood factors.
- Provide support for informal and formal assessment appeals.
- Provide documentation and ratio studies for DLGF review.
- Utilize a certified Level III Assessor-Appraiser to manage and oversee all services.

### 3. Contractor Requirements

- Must hold Level III Assessor-Appraiser certification under I.C. § 6-1.1-35.5.
- Minimum 20 years' experience in Indiana mass appraisal.
- Experience with CAMA system integration.
- Must reside in Indiana and be permanently onsite by May 1, 2026.
- Must comply with DLGF Contract Form #55930.

## 4. Proposal Requirements

Each proposal must include:

- Cover Letter and Executive Summary
- Qualifications and References
- Staffing Plan and Resumes
- Detailed Work Plan with Timeline
- Cost Proposal including per diem for overages

- Copy of Level III Certificate
- Acknowledgement of DLGF Form #55930 use

#### 5. Evaluation Criteria

Proposals will be evaluated based on:

- Compliance with statutory and DLGF requirements
- Qualifications and capacity
- Cost effectiveness
- Completeness and clarity of proposal
- Proven performance on similar projects

#### 6. Contract and Timeline

The selected Contractor must execute the DLGF-approved Form Contract #55930. Work must begin by May 1, 2026, and all contractual obligations, excluding appeals, must be completed by April 30, 2030.
